## TERMS AND CONDITIONS

We would like to inform you that you, as a customer (consumer), by using the website accessible at the <https://www.e-nevezes.hu> address (hereinafter referred to as the Denominator System), declare that you are aware of and accept the following general terms and conditions written pursuant to Sections 6:77-6:81 of the Civil Code (Act V of 2013). If you wish to be a customer or active user of the options offered by the Denominator System, please read our Terms and Conditions carefully and use our services only if you agree with all of its points and consider them binding on you.

This document is concluded exclusively in electronic form. A contract regulated by the following conditions is considered to be a distance contract concluded according to the Civil Code.

The service provider in these general terms and conditions is hereinafter referred to as the operator.

### 2. Range of products and services available for purchase

In the Entry System, it is possible to enter (register, order services) for sporting events. In some cases, in addition to applying for eligibility to participate, other products (such as T-shirts) may be associated with the entry.

### 3. Order information

Entry to tournaments in the Buy-in System is possible through the Buy-in System. Other buy-ins (e.g. by e-mail, in person) may be specified in the competition notices for each competition.

The prices of the entries are gross prices, the VAT content of which is 0%. A different VAT content is possible, however, this will always be disclosed in the competition notice.

If the operator indicates an incorrect price next to the service, despite the care that can be expected from him, and the price of the product differs from its generally accepted price, the operator is not

obliged to provide the service at the incorrect price, but is obliged to offer the customer the possibility of purchasing at a real price in the order confirmation. If the customer does not wish to make use of this option, he has the right to unilaterally withdraw from the contract.

The website does not provide delivery services, the ordered services and the related products can only be used in person at the venues specified in the competition announcement.

In the Denominator system, you can find information about the events of the current period on the landing page, and in the Events Calendar menu item, you can find information about the events of a period of your choice. In addition to the events, you can find their dates and locations. For more information about the event, click on the event name. This will take you to the event page, where you can get more detailed information about the event.

### **How to enter**

Entries to the event can be started from the event page. The entry process steps are as follows:

1. Provision of personal data
2. Enter entry details (category, T-shirt size, etc.)
3. Select payment method, enter billing information
4. Data verification
5. Finalize your entry
6. (Credit card payment at Barion)

A successful entry will be confirmed by email. The e-mail also contains the details of the entry and the generated unique entry ID.

### **4. Registration**

If you want to use the site to register for multiple events, you may want to register. Registration is optional, however, some events may require a registered account to enter.

There are no obligations to register.

### **5. Method of payment of the price of the ordered service**

Method of payment for the ordered product:

- By bank prepayment: if we have already confirmed your entry, you will find our bank account number and the entry ID in the confirmation email, which must be referenced in the note / announcement section of the transfer.
- By paying in cash in person: in this case, you will pay the buy-in and other related prizes in cash at the place and time specified in the competition notice.
- Online payment by credit card or Barion: through the Denominator System, with the assistance of Barion Payment Zrt. (registered office: 1117 Budapest, Infoparksétány 1. Building I, 5th floor, 5.; registry court: Court of Registration of the Metropolitan Court of Justice; company registration number: Cg. 01-10-048552; tax number: 25353192-2-43., VAT number: HU25353192; activity license number: H-EN-I-1064/2013, electronic money institution identifier: 25353192).. Payment by credit card is possible for holders of the following valid and effective bank cards: AmericanExpress, Mastercard, Maestro, Visa. Payment with Barion is available to customers who have a Barion wallet.

Not all payment methods are available for all events. Information about the available payment methods is provided in the competition announcement, and the system only allows you to choose from the available payment methods when entering.

The total amount to be paid includes all costs based on the confirmation letter. The requested invoice can be picked up at the event together with the starting package.

#### **6. Right of withdrawal**

Entries to the events can be cancelled within the deadline and on the terms and conditions specified in the competition notice.

#### **7. Warranty**

Entries are not relevant to the Denominator System due to the nature of the service.

#### **8. Handling of complaints**

The operator is obliged to draw up a report on the complaint, at the place indicated in the operator's data, and to keep the complaint for five years from the date of recording, together with the response to it. The operator shall examine the complaint received within 30 days of its receipt and shall provide a substantive response to it. If the operator provides a negative response to a complaint, he shall justify it in writing. Disputes arising from your contract with the operator can be resolved primarily amicably, by agreement between the parties or before the consumer protection authority competent for the consumer's place of residence. If these fail, the parties are left with the court.

#### **9. Data management**

The operator treats the personal data provided to it during the use of the Denominator System confidentially and does not disclose it to third parties. The details of data processing can be found in the Privacy Policy of the Southern Great Plain Sports District, the current version of which is available on [the https://www.e-nevezes.hu](https://www.e-nevezes.hu) page.

#### **10. Miscellaneous**

In matters not regulated by these general terms and conditions, the provisions of the Civil Code (Act V of 2013) and in the case of consumer contracts, the provisions of Government Decree 45/2014 on distance contracts shall apply.
